ACTEA Strategy Meeting

Last year, the ACTEA Council appointed a team to work on a new strategic plan (2022–2026). Guided by Prof. Emmanuel Bellon, Dr. Linzay Rinquest, and Dr. Evan Hunter of ScholarLeaders International, the team worked tirelessly. They conducted stake-holder and SWOT (strengths, weaknesses, opportunities, and threats) analyses in order to fully understand the task ahead and to have a robust strategic plan to guide ACTEA as we move forward.



ACTEA convened a panel of experts for a one-week meeting from 21–25 March 2022 at Brackenhurst Conference Center, Limuru, Kenya. In addition to ACTEA staff and ScholarLeaders representatives, attendees included leaders in theological education from across the continent.

In line with the Strategic Planning Committee recommendations, the team recommended several innovative changes. These include a revised governance structure, a revised mission statement, a new vision statement, and restated core values. ACTEA's mission statement has stated, "To strengthen member institutions in offering quality theological programs through accreditation, networking, and support services." Our new mission statement is "To strengthen theological education through accreditation, scholarship, and support services in order to serve the church and society." We believe that this proposed mission statement depicts the fundamental reason ACTEA exists and what it wants to accomplish and for what reason. We exist to strengthen theological education through accreditation, scholarship, and support services. To what end? For the sake of the church and society.

We have also proposed amendment of our vision (a description of what ACTEA should look like in the future if it is fulfilling its mission). Our vision has been

"a trusted association of theological institutions in Africa."

We are proposing a bolder vision:

"to see a vibrant African Church transforming society."

We believe this vision is bold and depicts the reason for our existence. We dream of a vibrant African church capable of transforming the African society. Our ministry is therefore to work towards realizing this great vision by strengthening theological education on our continent.

The Team also devised a new articulation of our core values with a short statement accompanying each:

1) Evangelical faith

To fortify theological education in Africa and for Africa, that identifies with the evangelical faith.

2) Professional excellence

To intensify commitment to quality among theological educators and their respective institutions, especially through accreditation services.

To unite theological educators and their institutions in service of the church in Africa and among Africans globally.

4) Contextual relevance

To engage theological educators and church leaders in addressing relevant issues facing the church and society in Africa through consultations, research, and publications.

5) Strategic collaboration

To collaborate with continental and global partners in providing support services for institutions running theological programmes



including Christian universities.

Strategic Initiatives:

ACTEA has framed eight strategic initiatives implemented with clear objectives and action steps. These eight strategic initiatives will structure and propel ACTEA ministry of strengthening theological education and the Church during the next five vears in Africa:

1) Organization, Leadership and Governance

Objective: reorganize ACTEA leadership and governance structure to serve its mission.

2) Accreditation and Evaluation

Objective: Enhance ACTEA's accreditation and recognition standards to serve theological education and the church in Africa.

3) Consultation, Research and Publications

<u>Objective</u>: Expand the influence of ACTEA by establishing Consultations, Research and Publications (CRP) division to serve theological education and the church in Africa.

4) Financial and Administrative Infrastructure

Objective: Develop a financial model to facilitate the vitality and sustainability of ACTEA ministry.

5) Capacity Strengthening Services

Objective: Enhance the capacity of member institutions, churches, and partners to equip the people of God for holistic mission.

6) Inclusion of all African Regions

Objective: Reposition ACTEA to serve theological education and the church among English, French, and Portuguese speakers in Africa.

7) Partnerships and Networks

Objective: Enhance partnerships and networks to leverage global resources for effective ministry.

8) Technology

<u>Objective</u>: Develop technology infrastructure for effective ministry.

Revision of ACTEA Standards

In line with our new strategic plan (initiative #2), ACTEA is in the process of updating its Standards and Guidelines, as these were last revised in 2011. A committee of five theological educators has been constituted for this purpose. The team will review the current standards in the light of the globalized ICETE standards and in the light of other factors we have identified in response to ongoing digitization and progressing technology, contextual issues, and concerns about outcomes of theological education (both academically and in terms of spiritual and character formation). How can ACTEA schools adapt to new ways of doing theological education? What are the intersections between formal and non-formal training? The Standards and Guildlines team has



worked virtually before meeting in Nairobi from June 27 to July 1, 2022. We hope to have a fair draft ready for circulation among ACTEA-related schools for their input later this month (August 2022). If feedback from stakeholders involves minor changes, the project editor can just adjust the document. If there are major issues, the project editor may need to go back to the committee for further input. Our plan is to submit the new standards to the Council in November for adoption.

Accreditation Visits

ACTEA staff have visited many schools since last year.

Africa College of Theology

Kigali, Rwanda

The assessment took place in response to ACT's application for accreditation of an additional programme (Post Graduate Diploma in Theology); this programme is already accredited by the Higher Education Commission of Rwanda. Dr. David Tarus, ACTEA Executive Director, undertook the assessment from 6-8 December 2021. The Accreditation Committee approved the accreditation of the programme.

Bible Institute of South Africa

Cape Town, South Africa

BISA applied for accreditation of an additional programme (MA in Linguistics and Translation). Dr. Ray Motsi, President of the Theological College of Zimbabwe (in Bulawayo), assessed the programme from 19th to 22nd January 2022. Having reviewed the assessor's report, the Accreditation Committee has approved the programme for accreditation..

Baptist Theological Seminary Kaduna

Kaduna, Nigeria

BTSK applied for ACTEA Affiliate accreditation on 7 December 2021. This visit was undertaken by Dr. David Tarus, Executive Director of ACTEA on 2-3 February 2022. The Accreditation Committee approved the accreditation of the following programmes: Residential Diploma in Theology (Dip.Th.); Regular and part-time Bachelor of Theology (B.Th.); Residential Bachelor of Religious Education (BRE); Regular and part-time Master of Divinity (MDIV); and Residential Master of Theology (M.Th.). Note well that their Master of Arts in Theological Studies (MATS) is **not** ACTEA-accredited.

Ethiopian Graduate School of Theology

Addis Ababa, Ethiopia

A team of 6 theological educators together with the ACTEA Administrator visited EGST for re-accreditation assessment from 3-10 April 2022. The reaccreditation report is in progress

Ethiopian Kale Heywet School of Mission and Theology

Durame-Teza, Ethiopia

EKSMT-Durame-Teza applied for ACTEA Affiliate accreditation on 8 December 2021. This visit was undertaken by Dr. David Tarus, Executive Director of ACTEA, Mrs. Florence Kagwamba, ACTEA Administrator, and Dr. Endale Sebsebe, President of Shiloh International Theological Seminary, Hawassa,





Ethiopia 24-25 February 2022. on The Accreditation Committee (AC) approved accreditation of their Diploma in Theology, Diploma in Missions, Bachelor of Theology and Bachelor of Missions, offered in English at three campuses: EKSMT-Durame-Teza, Shinshicho, and Halaba.

Ethiopian Kale Heywet Ministers Training Hosana, Ethiopia College-Hosana

EKMTC-Hosanna applied for ACTEA Affiliate accreditation on 8 December 2021. This visit was

undertaken by Dr. David Tarus, Executive Director of ACTEA, Mrs. Florence Kagwamba, ACTEA Administrator, and Dr. Endale Sebsebe, President of Shiloh International Theological Seminary, Hawassa, Ethiopia, on 22-23 February 2022. The Accreditation Committee approved accreditation of at the affiliate level of their residential Diploma in Theology offered at the main campus, Hosanna, Ethiopia, and residential and evening Bachelor of Theology programme offered at the main campus, Hosanna, Ethiopia, and at the KHC-Hosanna church compound respectively.

Ethiopian Kale Heywet Church Ministry Training College Dilla, Ethiopia

The reassessment of EKMTC-Dilla was conducted by Dr. David Tarus, Executive Director of ACTEA, Mrs. Florence Kagwamba, ACTEA Administrator, and Dr. Endale Sebsebe, President of Shiloh International Theological Seminary, Hawassa, on 28 February 28 – 1 March 1 2022. The Accreditation Committee deferred the award of Affiliate Status Accreditation on EKMTC-Dilla pending submission of the College's written response to the Report and achievement of greater compliance with ACTEA Standards.



Jos ECWA Theological Seminary

Jos, Nigeria

JETS applied for Affiliate Status on 25 February 2021. This visit was undertaken by Rev. Professor Emmanuel O. Oyemomi, Rev Dr Cletus C. Orgu, and Prof Samuel Peni Ango from 31 January to 4 February 2022. The Accreditation Committee is currently reviewing the report.

Kenya Baptist Theological College

Tigoni, Limuru, Kenya

KBTC applied for affiliate accreditation on 6 July 2021. The assessment was undertaken by Dr. John Jusu OCI Africa Regional Director and Florence Kagwamba Executive Administrator of ACTEA from 11-12 November 2021. The Accreditation Committee deferred the accreditation until such a time that KBTC administration addresses the significant issues raised in the assessment report.



Leadstar Theological College

Addis Ababa, Ethiopia

LTC applied for ACTEA Affiliate accreditation on 1 October 2021. The visit was undertaken by Dr. David Tarus, Executive Director of ACTEA, Mrs. Florence Kagwamba, ACTEA Administrator, and Dr. Alemseged Ketema, Head of Graduate Studies, Evangelical Theological College, Addis Ababa, Ethiopia. The assessment took place on 3-4 March 2022. LTC is seeking ACTEA accreditation for the following programmes: Bachelor of Theology (B.Th.) and Master of Arts with different specializations (Theological and Biblical Studies, World Mission, Pastoral Counselling, Christian Leadership, and Community Development). The Accreditation Committee voted to defer the award of Affiliate Status Accreditation on LTC until written response to the Report is submitted and greater compliance with ACTEA Standards is achieved.

Reuben George Theological Seminary

Ibadan, Nigeria

REGETS applied for Affiliate accreditation on 5 June 2019. The assessment was conducted by Rev. Professor Emmanuel Oyemomi, on behalf of ACTEA Executive Director, Dr David Tarus in Nairobi, Kenya on 22-24 September 2021. The Accreditation Committee (AC) posed several questions to REGETS administration, which they have addressed. The AC is reviewing the report and shall make a decision in the coming weeks.

TheoGlobal: Theology Today

ACTEA's TheoGlobal Conference (TG) for Eastern Africa, formerly know as Global Theological Initiative (GTI), took place from 30 June - 2 July 2022 in Nairobi. This event for post-doctoral scholars was co-hosted by ACTEA and by Sola Media, based in the USA. The 2022 TheoGlobal Conference brought together 37 post-doctoral theologians from countries throughout the East Africa and Horn of Africa regions



(Burundi, Ethiopia, Kenya, Rwanda, South Sudan, Sudan, Tanzania, and Uganda) along with Malawi, India, and the United State. The theme for 2022's conference was "Between Two Ages: Christ's Reign and Our Future Hope." The conference included theological presentations from and dialogue with African and American scholars.
